Workflow and weighting of criteria in the Match'In project

Weighting of the criteria for the distribution of protection seekers (for iteration 1: only single persons of legal age without family ties, as of January 2024)

As part of the data collection process, participants are first asked about aspects that could potentially prevent them from participating in the matching process. These exclusion criteria arise in particular from the fact that those seeking protection should not be disadvantaged by participating in the project: If conditions exist that make the distribution to a specific municipality appear particularly sensible or legally necessary, participation is therefore discontinued and distribution to the relevant municipality is recommended directly.

<u>1) Exclusion criteria</u>:

If there is a criterion that prevents participation in matching, data collection will be terminated immediately. Distribution as part of a family group or desire to join a family (nuclear family in Germany).

2) Possible exclusion criteria

In addition to the mandatory exclusion criteria (see 1.), there are other possible exclusion criteria. In the case of these, it is possible, but not absolutely necessary, to discontinue participation - the respondents can decide for themselves by providing the relevant information on the questionnaire. These criteria only lead to discontinuation and direct recommendation to the respective municipality if the persons explicitly requests this themselves.

Matching criteria:

If participation was not excluded, the following criteria are collected as matching criteria and included in the distribution decision with their respective weights.

Basic rules for weighting by the algorithm:

- a) All **main criteria** or categories (respective heading of the tables, e.g. "personal data" or "work") are **weighted equally** by the **algorithm**. Accordingly, these categories each have the same weight for the algorithm's distribution proposal.
- b) The grouping into categories also means that the **weighting entered** (column 4) only represents a weighting of the **sub-criteria within the respective category** (i.e., between the sub-criteria within the category "personal data" or "work"). Weightings of sub-criteria are therefore not directly comparable between the grouped categories.
- c) At least one sub-criterion under each main category must be answered during data collection (protection against skipping entire blocks of questions and thereby skewing the weighting).
- d) Special protection needs play a separate role: Here, in contrast to the other main criteria, each applicable criterion is weighted individually, not the entire category in a fixed sum. The individual weights of the sub-criteria under special protection needs are added together and thus result in an individual total that is based on the specific needs of a person. This procedure is necessary in order to take into account the possible existence of mutually reinforcing, intersectional special protection needs.

As part of the data collection surveys, participants are given the opportunity to go beyond the standard weighting by the algorithm and **give double weighting** to a category that is particularly important to them.
